Requirements:

- Open class dairy cattle entries must be postmarked by July 25th.
- Exhibitors must be 18 years and older to show in the open class.
- Open Class dairy cattle entries will be accepted from exhibitors within or outside of Oconto County.
- First barn space preference will be given to Junior Fair exhibitors followed by Open Class exhibitors who
 are residents of Oconto County, cattle housed in Oconto County, or past exhibitors of the Oconto County
 Fair, then out of county exhibitors.
 - Entries will be accepted based on the date entry is received up to the limit of barn space available.
 - Open Class exhibitors will be notified by August 5th if entries cannot be accepted due to space limitations.
- Out of county exhibitors will be charged stall fees as follows:
 - \$5 per head calves and yearlings
 - o \$10 per head cows
 - Fees are to be submitted with entry forms.
 - o Fees are non-refundable for no-shows
 - → Fees will be refunded if space is not available.
- WDATCP requires the Fair to maintain records of exhibitors, animal ID, and premise ID where available, for dairy cattle that are exhibited. Permanent identification may be breed registration papers; tattoo; or ear tag. Exhibitors using ear tags for identification are responsible for replacing lost tags and reporting old and new tag numbers to department superintendent, Erin Buhrandt.
- Purebred and Grade Red and White cattle must be red and white to show. No black cattle may be shown in this class.
- All health requirements must be met before the animals are entered. See current Health Requirements Section of premium list.
- Exhibited animals will be inspected at check-in on the trailer for ringworm, mange, warts, and other health conditions. Suspect animals will be isolated and checked by the fair veterinarian. Infected animals will be sent home by the vet.
- Exhibitors are to call their own veterinarian for emergency or non-emergency animal health issues with their exhibits while at the fair. Exhibitors calling the fair veterinarian to see animals at the fair will be charged that doctor's normal stop charge plus treatment costs for the call.
- Dairy cattle with horns longer than 1" (measured from the hair line), will not be permitted to show. Loosely attached spurs (not attached to the skull) are allowed.

- The use of power washers is not allowed at the fair and no electrical equipment is permitted in the wash
 rack areas.
- The fair expects exhibitors to maintain neat displays, focus exhibits on displaying cattle, and maintain adequate alley space for safely moving cattle and Fair visitors. To meet these goals:
 - Feed stored in display area is limited to no more than one stack of small, square bales, 4 bales high. Additional feed may be stored in trailers in designated parking areas.
 - Show boxes may be placed at the outside of gates on ends of barn.
 - o Exhibitors across alleys are jointly responsible to maintain a clear and clean 8-foot wide alley.
 - Areas along the inside walls of alleys to wash racks are not to be used for feed storage or show boxes.
- Barn exhibit decoration rules:
 - A 16-inch wide, continuous background plywood strip is provided over all animal exhibit areas. This strip is the only area that is to be used for animal ID and decorations.
 - Decorative panels that are close to 16 inches wide may be attached to the background strip. Or decorations may be attached directly to the plywood strip.
 - Electric lights are prohibited as part of exhibit decorations.
 - o Floor displays are prohibited to insure adequate space for livestock exhibits.
- Tardy exhibitors in any dairy show will be called to the ring two times, after which judging of the class will begin without the tardy exhibitors.
- For class definitions, see Chapter ATCP 160.08 and 160.09 in the general information section of the premium list.
- Registered and grade cattle of all breeds will be shown together in classes, except Holsteins.
- Regular judging will be used in the Open Class division. Only one (1) First, Second, Third and Fourth placing and premium will be awarded per class.
- Groups or individuals not providing adequate care for their exhibit animals will be verbally warned by the
 department superintendent. If the situation is not resolved after one warning the superintendent will refer
 the offender(s) to the fair board dairy committee, which may order the animals removed from the fair if
 improved care is not provided.
- The milk house hours will be set and posted at the fair after superintendents and milk house supervisor consult with exhibitors. Note: The fairgrounds milk house will not be open for milking Thursday. If milking cows at home before bringing them to the fair would mean missing the entry closing time contact a dairy superintendent to make arrangements for late arrival. All cattle must arrive at the fair Thursday evening.
- All milk produced at the Fair becomes the property of the Fair. Proceeds from the sale of milk at the Fair is
 used to cover the cost of milking supplies, maintenance of equipment above that provided by donor of the
 equipment, and the time of the milk house supervisor.
- The use of privately owned portable milking equipment at the fair is prohibited.
- Exhibitors are responsible for insuring the safety and wholesomeness of the animal-derived food they are
 producing and exhibiting at the Fair. The milk house supervisor or their designee collects samples from
 each milking of each individual cow milked at the Fair for testing in the event contamination is found. The
 exhibitor contaminating commingled milk will be responsible for financial losses incurred by the Fair, milk
 hauler, and dairy processor due to contaminated milk by illegal residues and may be liable for additional
 sanctions under state and federal regulations.
